HB 318 PRIMARY ELECTION (Blessing, L.) To revise the process for becoming a candidate for nomination for the office of President of the United States, to establish a separate primary election on June 12, 2012, for nominating candidates for the offices of President and Vice-President of the United States, candidates for the office of member of the United States House of Representatives, candidates for at-large delegate and alternate to the national convention of a major political party, and candidates for district delegate and alternate to the national convention of a major political party, to eliminate the August special election in 2012, to permit political subdivisions and taxing authorities to conduct a special election on the day of the June 12, 2012, primary election, and to make an appropriation. Proposed Infectious Waste Regulatory Reform

Background

Since 1988, Ohio EPA has regulated the generation, treatment, packaging, storage, transportation, and disposal of infectious waste in the state. Since that time, the Occupational Safety and Health Administration (OSHA) has promulgated regulations for the storage and management of infectious waste (1991) while the Department of Transportation (DOT) has promulgated regulations for the labeling, packaging and transportation of infectious waste (2002). This has resulted in dual and duplicative regulation and oversight of infectious waste generators and transporters.

Ohio EPA has evaluated its statute and regulations regarding the generation, treatment, packaging, storage, transportation, and disposal of infectious waste in light of OSHA and DOT's regulations and has identified several areas where we can streamline our regulations, specifically in the management of infectious waste prior to and during transportation, while still maintaining a program protective to human health and the environment. The following is a summary of the proposed infectious waste regulatory program in Ohio:

Notification / Registration of Infectious Waste Generators

- Each infectious waste generator location will be required to notify Ohio EPA of their status as an infectious waste generator regardless of amount of infectious waste they generate.
- Each infectious waste generator will be required to update their notification when information changes or at least biennially.
- Notifications will require the payment of a processing fee, except for small generators (those who generate less than 50lbs/month).

Management of Infectious Waste

- An infectious waste generator must segregate infectious waste from solid waste once generated.
- An infectious waste generator must ensure their infectious waste is lawfully treated and disposed.

Proposed Infectious Waste Regulatory Reform

Transportation of Infectious Waste

- If not treated on-site, each infectious waste generator's waste must be transported off-site in accordance with USDOT/PUCO requirements.
- Infectious waste must be treated before being disposed of in a sanitary landfill.

Treatment of Infectious Waste

• Infectious waste treatment facilities will remain subject to permitting and licensing requirements under Ohio Revised Code 3734.

Liability Associated with the Management of Infectious Waste

- Infectious waste generators who violate any of the Ohio infectious waste rules will remain liable for any damage or injury caused by the violation and for the costs of rectifying the violation and conditions caused by the violation in addition to any civil penalties or criminal fines.
- Infectious waste transporters shall not accept for transportation or for treatment, storage, or disposal any infectious waste whose generator has violated any of the Ohio infectious waste rules.
- Anyone who accepts for treatment, storage, or disposal any infectious waste and who violates
 any of the infectious waste rules will remain liable for any damage or injury caused by the
 violation and for the costs of rectifying the violation and conditions caused by the violation in
 addition to any civil penalties or criminal fines.
