# Key Advocacy Victories

- ✓ Secured Governor DeWine's signature on bills that enable podiatrists to administer the flu, COVID-19 vaccines to patients
- ✓ Advocated to make permanent Medicaid telemedicine rules that helped podiatrists care for patients during the pandemic
- ✓ Protected podiatrists from civil liability and disciplinary actions relating to the COVID-19 pandemic
- ✓ Ensured new Medicaid rules included ankle privileges in our scope of practice and authorized payment for vaccinations

# Scope of Practice Challenge

- ▶ Preserved podiatrists' ability to:
  - ▶ Perform supramalleolar osteotomy of the tibia or fibula to correct a deformity
  - ▶ Harvest bone marrow aspirate from proximal tibia
- ▶ State Medical Board of Ohio withdrew pro-podiatry letter
- ▶ Decisions on credentialing and privileging podiatrists moved to hospital level

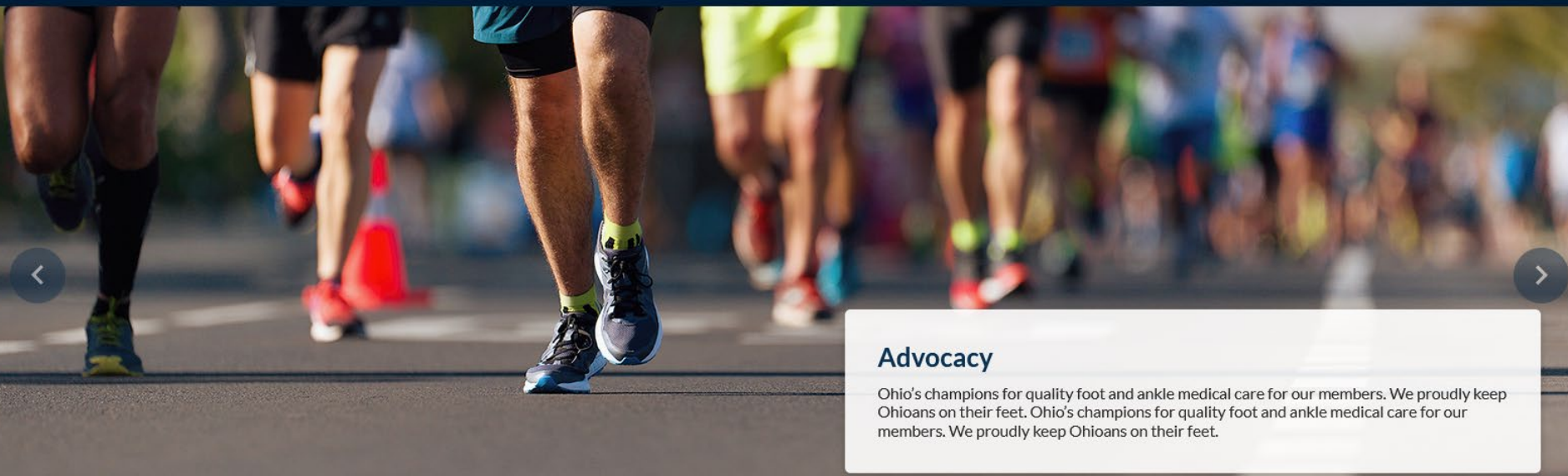

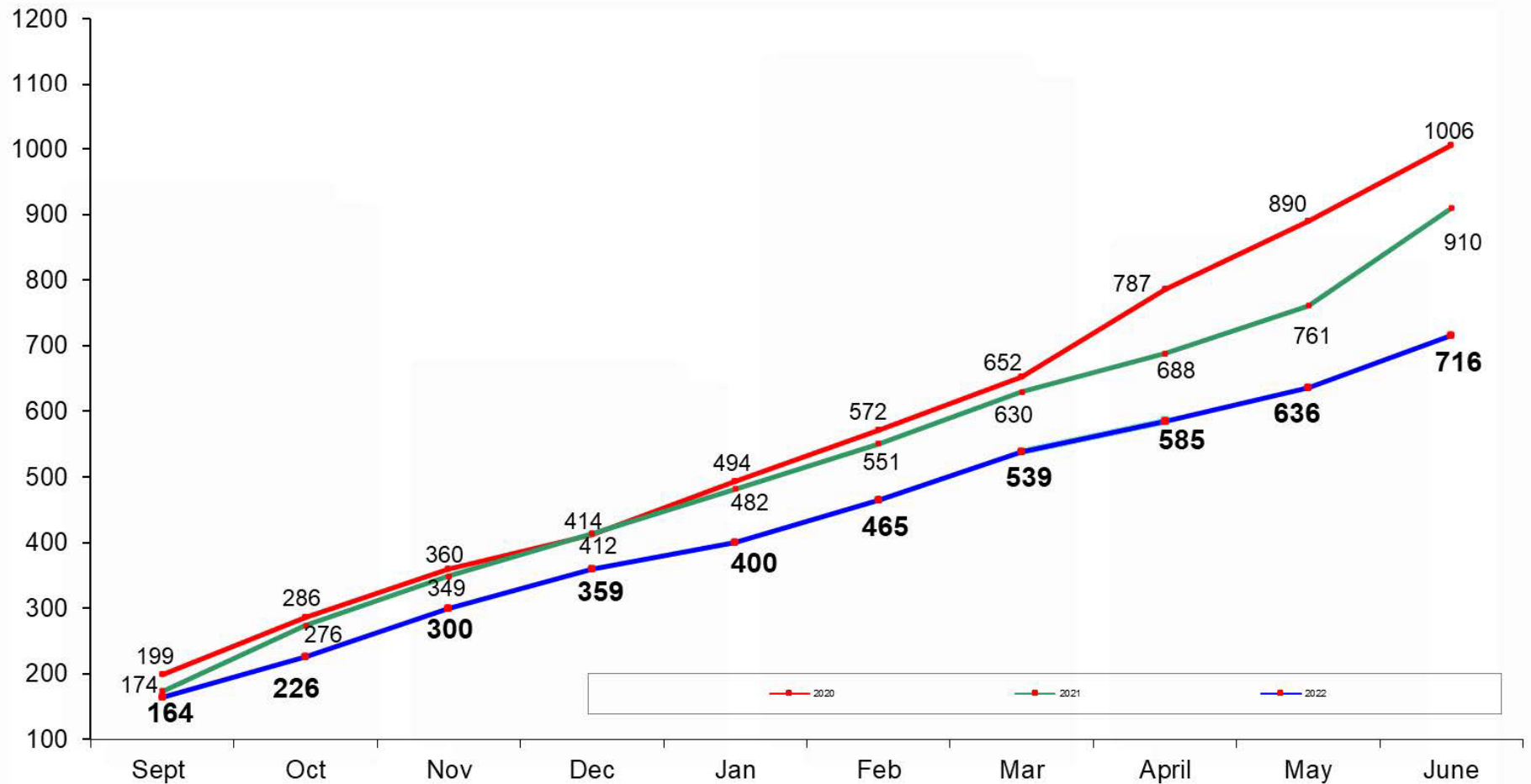
# Student Recruitment

- ▶ In 2022, there was a 21% decrease in applicants to podiatric medical school
  - ▶ 716 applicants for 697 positions at nine podiatric medical schools
- ▶ Applications to allopathic medical schools increased 18% in 2022 compared to 2021
