### **KSUCPM Seeks State Funding**

Did you know Kent State University College of Podiatric Medicine (KSUCPM) is the only medical school in the state that does not receive State Share of Instruction (SSI) funds?

SSI funding represents taxpayers' investment in higher education. This critical support reduces tuition for in-state students and enhances clinical and research opportunities for medical students.

It is time for the Ohio General Assembly to fix this disparity and provide SSI funding to KSUCPM.

Kent State University, working with Senators Jerry Cirino and Vernon Sykes, has prepared a budget amendment that would include KSUCPM students in the Medical 1 SSI funding line, which is currently divided among Ohio's public in-state veterinary and dentistry students. The amendment would "hold harmless" other Medical 1 students while providing over \$3 million to support reducing tuition for Ohio's podiatric medical school students.

If the budget amendment is ultimately signed into law, KSUCPM estimates Ohio's in-state graduates would earn their degrees with a nearly 30% decrease in student debt.

In addition, inclusion in the Medical I line would allow KSUCPM to:

- Develop, maintain, and upgrade patient simulation instruction and interprofessional educational opportunities
- Improve clinical student experiences through enhanced educational experiences
- Increase the number of dedicated, paid part-time adjunct clinical faculty and lower its student to faculty ratio
- Improve student experiences with virtual anatomy and handson training for podiatric procedures
- Upgrade the radiology teaching center to utilize the technology used in hospitals and other universities, including digital radiography with appropriate monitors and viewing stations
- Enhance research capabilities aimed at amputation reduction in Ohio's growing diabetic population

KSUCPM is one of eleven podiatric medical schools in the country and over 80% of licensed Ohio podiatrists who live in Ohio graduated from KSUCPM (or its predecessor, Ohio College of Podiatric Medicine). Moreover, over 75% of the nearly 150 residents currently training in Ohio are KSUCPM graduates.

Considering the average age of practicing Ohio podiatrists is 50.2 years old, and applications to podiatric medical schools declined significantly in recent years, now is the time for the Ohio General Assembly to address the inequity in the SSI funding formula and financially support podiatric medical education in our state.

OHFAMA is asking all members to submit a letter to their elected leaders in the General Assembly to support KSUCPM's quest to secure state funding. Please check your email for instructions on how to quickly send a message to your legislators via APMA's eAdvocacy system.

With your help, we can support KSUCPM's efforts to ensure our podiatry workforce remains strong and vibrant into the future.

### **Boyle Appointed to State Medical Board of Ohio**

Ohio Governor Mike DeWine announced the appointment of John Boyle, DPM, to a five-year term on the State Medical Board of Ohio.

Dr. Boyle, of Chillicothe, established a solo practice, Southern Ohio Foot and Ankle Associates, in 1984 and is currently affiliated with Adena Regional Medical Center. He is a 1977 graduate of Ohio Dominican University, a 1982 graduate of Ohio College of Podiatric Medicine, and completed his residency at Colemery-O'Neil Veterans Administration Medical Center in Topeka, Kansas in 1983.

Dr. Boyle is Certified in Foot Surgery by the American Board of Foot and Ankle Surgery a Certified Wound Specialist by the American Academy of Wound Management.

The State Medical Board of Ohio is comprised of twelve members, including seven allopathic physicians, one podiatric physician, one osteopathic physician, and three non-physician public members. The Board is responsible for licensing and regulating physicians, physician assistants, respiratory care professionals, and other health care professionals.

### In Appreciation: Dr. Bruce Safrin

Dr. Bruce Saferin's term on the State Medical Board of Ohio expired on December 27.

During his tenure on the Board, which began in 2013, Dr. Saferin earned the respect of his colleagues who elected him Supervising Member. He further represented Ohio on the Board of Directors of the Federation of Podiatric Medical Boards, where he served as president in 2020-21.

Dr. Saferin is a longtime OHFAMA member who served as trustee, secretary, and president of our organization in a span of 40 years. He similarly served in a variety of leadership roles in the American Podiatric Medical Association and Northwest Ohio Academy of Podiatric Medicine.

His longstanding service to OHFAMA and the State Medical Board of Ohio has positioned Dr. Saferin as a trusted podiatry advocate who personifies our mission to protect the public's foot health and advance the professional practice of podiatric medicine and surgery in Ohio.

### Podiatry Rules Up for Five-Year Review

The rules governing the definition of the foot and outlining the qualifications to perform surgery on the ankle joint will be reviewed starting on May 31 as part of a mandatory five-year review process.

As part of this process, the State Medical Board of Ohio will seek public comment from licensees and the public on the rules for possible amendments. OHFAMA will submit comments endorsing the current rules and monitor comments submitted by other parties throughout the multi-month rules review process.

## Department of Medicaid Budget Includes Reimbursement Increase for Podiatrists

Through OHFAMA's lobbying efforts, the Ohio Department of Medicaid (ODM) budget includes a 5% increase in the Medicaid reimbursement rates for podiatrists.

The change was included in Governor Mike DeWine's budget proposal, which is now before the Ohio Senate for consideration.

OHFAMA Executive Director Mike Mathy testified before the Health and Human Services Subcommittee on March 22 to ask committee members to support ODM's budget recommendation and consider further boosting Medicaid reimbursement rates for podiatrists.

"Podiatry has always been an important part in the team concept of care in Ohio's Medicaid system, but like other providers, costs to administer care have significantly gone up for our members while reimbursement levels have remained flat," said Mathy. "OHFAMA members

would appreciate your support of Medicaid's initial 5% reimbursement increase for podiatric physicians and surgeons contained in House Bill 33 and strongly consider building on that 'good start' by allocating an additional 5% in reimbursement levels for our valued providers."

House Bill 33 passed the Ohio House of Representatives on April 26 and must be approved by the Senate and be signed into law by Governor DeWine by June 30.



### **OHFAMA Supports Prior Authorization Gold Card Legislation**

Proposed bill would ease regulatory burden of prior authorization, improve healthcare system and outcomes for patients.

OHFAMA joined a coalition of healthcare associations in March to support House Bill 130, sponsored by Representative Kevin Miller (R-Newark), which would create a Prior Authorization Gold Card Program for Ohio healthcare providers.

The process of getting prior authorization is frequently cited by all within the health care community as a major contributor to administrative burden, frustration, and hassle, and frequently causes roadblocks to care that increase risk of poor health outcomes and harm to patients.

This legislation will create a process to reward high performing health care providers who are consistently adhering to evidence-based medicine by exempting those providers from prior authorization requirements.

We applaud Rep Miller for attempting to reduce the barriers to care all Ohioans face by streamlining the prior authorization process and eliminating red tape and excessive overregulation of the health care community and the patients we proudly serve.

HB 130 was introduced on March 30 and referred to the House Insurance Committee. We will continue to provide updates to the OHFAMA community as the legislation makes its way through the legislative process.

### New Cigna Policy Requires Office Notes for E/M Codes

APMA joined several medical specialty and other organizations in signing a letter sponsored by the AMA asking Cigna to immediately rescind its policy requiring submission of office notes with all claims, including evaluation and management (E/M) CPT codes 99212, 99213, 99214,

and 99215 and modifier 25 when a minor procedure is billed.

The coalition of organizations urged Cigna to reconsider this policy due to its negative impact on practice administrative costs and burdens across medical specialties and geographic regions, as well as its potential negative effect on patients, and instead partner with our organizations on a collaborative educational initiative to ensure correct use of modifier 25. APMA will also continue to reach out to Cigna directly to contest these policies.

Under the new policy, which is effective June 11, 2023, claims will be denied if a provider fails to submit supporting documentation. Members can find guidance regarding documentation guidelines for significant and separately identifiable E/M services at www.apma. org/25modifier.

### **Medicare's Surgical Treatment of Nails Policy**

Members have been contacting us about "global periods" on 11730, 11732, and 11750.

The Centers for Medicare and Medicaid Services (CMS) has implemented a policy, apparently on a national level, concerning the surgical treatment of nails. This policy establishes utilization parameters regarding the use of CPT®111730 and 11732. The policy states:

A medically reasonable and necessary repeat CPT 11730/11732 of the same nail within 32 weeks of a previous avulsion will be considered upon redetermination.

APMA released a statement on this earlier in the year and I have included it for your benefit:

On January 10, APMA met with CMS to discuss ongoing concerns with CMS' direction on local policies related to Surgical Treatment of Nails (CPT 11730/11750). APMA focused on the clinical issues with these policies, as well as the clumsy way these policies were initially implemented and then later modified or significantly changed by the contractors with no notice or opportunity for comment. APMA suggested changes to the process including opportunity for comment as well as changes to the policy to allow for repeat procedures to support sound clinical practice and to improve patient care. CMS is reviewing the information that APMA provided and will be meeting with APMA to follow up on these issues.

On February 8, APMA held a follow-up call with CMS to discuss CMS' responses to APMA's concerns and to once again call for the ability to append a modifier to claims to indicate that what CMS is referring to as "repeat" was actually medically necessary and should be paid on initial submission without having to go through the redetermination process.

CMS is considering potential solutions and will notify APMA when those solutions have been determined and finalized. In the meantime, APMA has created a resource page for members at www.apma.org/surgicalnail; the page contains a recorded video that outlines coding for CPT 11730, 11732, and 11750, and the necessity of submitting a redetermination for certain claims when initially submitted and denied. It also outlines APMA's most up-to-date advocacy efforts, as well links to the guidelines covering these services.

#### Skin Substitute Draft LCD

There is still no final decision regarding the reworking of a draft Local Coverage Determination (LCD) related to Cellular and Tissue Based products (CTPs) for the treatment of diabetic foot ulcers and venous leg ulcers.

If you recall, stakeholders had the opportunity to submit statements back in late 2022. APMA sought feedback from our CGS CAC representatives in Ohio and Kentucky and collaborated with APMA's Clinical Practice Advisory Committee (CPAC) in developing comments.

In its letter, APMA underscored the medical, social, psychological, and financial burdens that chronic wounds present for patients and health systems and took exception to limitations on the number of applications of CTPs, required use of RT or LT Modifier, and the incomplete set of included ICD-10 codes.

As of today, the Medicare website shows no anticipated date for the final LCD publication.

### Call to Action: Anthem Bundling Low-Level E&M Procedures

Anthem has been bundling low level E&Ms into procedures. If this has happened to you, please let OHFAMA know and submit redacted paperwork to help us counter this!

### National Correct Coding Initiative (NCCI) Names New Contractor

The Centers for Medicare & Medicaid Services (CMS) National Correct Coding Initiative (NCCI) has a new contractor. This is exciting news and we hope to be able to address concerns that were previously not addressed to our satisfaction.

### Updated Advance Beneficiary Notice Form, Instructions Approved

The Office of Management and Budget announced the Advance Beneficiary Notice of Noncoverage (ABN), Form CMS-R-131, and form instructions have been approved.

The use of the renewed form with an expiration date of 01/31/2026 will be mandatory on 6/30/23. Providers may continue to use the ABN form with the expiration date of 6/30/23 until the renewed form (expiration date 01/31/2026) becomes mandatory on 6/30/23.

ABN forms are issued by providers (including independent laboratories, home health agencies, and hospices), physicians, practitioners, and suppliers to Medicare beneficiaries in situations where Medicare payment is expected to be denied. The ABN is issued to transfer potential financial liability to the Medicare beneficiary in certain instances.

### In Memoriam

OHFAMA is saddened to report the passing of two dedicated members of our profession.

### William Saar, DPM

Dr. William Saar passed away April 23. Born May 25, 1944, in Williamsport, PA, Dr. Saar received his doctorate of podiatric medicine from the former Ohio College of Podiatric Medicine now Kent State University College of Podiatric Medicine.

Following a half century of dedicated service to clinical care and leadership he retired in 2019. He served as Administrative Director of Podiatric Medical Services and Director of Podiatric Medical Education. He also served as administrator for the program directors, fellowship directors, and on-site podiatric supervisors at all University Hospitals locations.

Under Dr. Saar's leadership the residency program became one of the largest and most successful podiatric training programs in the U.S. Dr. Saar was co-founder of the Center for Comprehensive Wound Treatment and served as Medical Director of the Wound Care Center at UH Richmond Medical Center. He was an adjunct faculty member of the Kent State University College of Podiatric Medicine and Ohio Heritage College of Osteopathic Medicine.

### Eric Polansky, DPM

Dr. Eric Polansky passed away on Sunday, April 2. Dr. Polansky was a longtime member of the Midwest Academy who was the founder and director of Advanced Foot and Ankle Care Centers in Sidney, Pigua, Huber Heights, and Troy.

Born April 15, 1956 in Sharon, Pennsylvania, Dr. Polansky graduated from Hermitage High School and went on to attend Edinboro University, obtaining a Degree in Biology. His athletic career drew him to the field of medicine and he attended Pennsylvania State University graduate school before graduating from Temple University earning a Doctor of Science in Podiatric Medicine. Dr. Polansky continued his scholastic endeavors graduating from a comprehensive surgical residency program at Riverside Hospital, Toledo, Ohio.

Dr. Polansky was board certified and an active member of both the American College of Foot and Ankle Surgeons and the American Board of Podiatric Surgery and a Fellow of the American College of Foot and Ankle Surgery. He was proudly on staff at Wilson Hospital, Upper Valley Medical Center and Miami Valley North, Dayton, Ohio.

### Want Your New 401(k) Plan to Cost Nothing? Check this out!

If cost has prevented you from adopting a new retirement plan, you might want to zero in on this feature of the new SECURE Act 2.0: you may not have to pay any fees for the first 3 years!

Small employers (50 or fewer employees) will receive a tax credit of 100% of the cost to start and administer a new retirement plan, up to the lesser of \$5,000 or \$250 times the number of non-highly compensated employees. This would cover most, if not all, of the cost to get the plan up and running the first year. And would likely cover the full cost of administering the plan for the next two years. (Reduced credits are also available for employers with 51-100 employees.)

In addition to this tax credit, the OHFAMA Members' 401(k) Exchange Plan is a great way to join forces with your fellow members to reduce the expense and fiduciary liability of operating a 401(k) plan. You may pay

NOTHING for your start-up 401(k) for at least 3 years. A plan with zero assets will have an installation cost of \$1,000, a maximum annual administration fee of \$2,500 (or less, depending on plan design), and a per-participant charge of \$25. Even with 50 employees, the top fee would be:  $$1,000 + $2,500 + (50 \times $25) = $4,750$ . ALL of that would be paid for by the tax credit for three years! As assets grow, the fees reduce, giving you three years to get to the "sweet spot" with no billed fees.

Still not convinced? What if contributions of up to \$1,000 for each employee earning less than \$100,000 also get a tax credit? Let's say you have 20 employees; you give each of them a \$1,000 contribution, \$20,000 total, and it costs you nothing as the business owner! This full credit is available for the first two years, reducing to 75% in the third year, 50% in the fourth, and 25% in the fifth year. AND if you have automatic enrollment as a feature of your 401(k) Plan, there is an additional \$500 credit for the first three years.

By now, you must be asking, "Why would the government do this?" Over 40% of workers in the United States do not have access to an employer sponsored retirement plan. As a result, most of those employees won't save for retirement and will be relying on Social Security, a program which is expected to become insolvent by 2034. While most large companies offer a retirement plan, many small employers say it is too expensive to start and maintain a plan. So, the government is throwing everything they can into encouraging small employers to start a new plan.

### New Opioid Training Requirements Impact DEA Licensees

On December 29, 2022, the Consolidated Appropriations Act of 2023 enacted a new one-time, eight-hour training requirement for all Drug Enforcement Administration (DEA)-registered practitioners on the treatment and management of patients with opioid or other substance use disorders. Below is information on this new requirement.

### Who is responsible for satisfying this new training requirement?

■ All DEA-registered practitioners, except for practitioners that are solely veterinarians.

### How will practitioners be asked to report satisfying this new training requirement?

Beginning on June 27, 2023, practitioners will be required to check a box on their online DEA registration form—regardless of whether a registrant is completing their initial registration application or renewing their registration—affirming that they have completed the new training requirement.

#### What is the deadline for satisfying this new training requirement?

■ The deadline for satisfying this new training requirement is the date of a practitioner's next scheduled DEA registration submission—regardless of whether it is an initial registration or a renewal registration on or after June 27, 2023. This one-time training requirement affirmation will not be a part of future registration renewals.

### How can practitioners satisfy this new training requirement?

- Practitioners can satisfy this training by engaging in a total of eight hours of training on treatment and management of patients with opioid or other substance use disorders from the groups listed below. A few key points related to this training:
  - The training does not have to occur in one session. It can be cumulative across multiple sessions that equal eight hours of training.
  - Past trainings on the treatment and management of patients with opioid or other substance use disorders can count towards a practitioner meeting this requirement. In other words, if you received a relevant training from one of the groups listed below prior to the enactment of this new training obligation on December 29, 2022 that training counts towards the eight-hour requirement.
  - Past DATA-Waived trainings count towards a DEA registrant's 8-hour training requirement.
  - Trainings can occur in a variety of formats, including classroom settings, seminars at professional society meetings, or virtual offerings.

### Deja Vu or a Glitch in the Matrix: The End of the Public Health Emergency

Prepare for another big shift in health care operations. On January 30, 2023, President Joe Biden announced he would not extend the COVID-19 Public Health Emergency (PHE) beyond its current expiration date of May 11, 2023.

The PHE was declared by former President Donald Trump in March of 2020 as COVID-19 began to spread around the nation. The waivers and other regulatory changes instituted in its wake have impacted nearly every facet of health care services. The expiration of the PHE will bring about the termination of several policy waivers and discretionary enforcement that have expanded federal health care programs, payments, and prescribing flexibilities to millions of Americans.

#### **Approaching Reversions**

A big point of uncertainty is the fate of telemedicine prescribing after May 11. Under non-PHE conditions, the Controlled Substances Act (CSA) — as modified by the Ryan Haight Online Pharmacy Consumer Protection Act of 2008 — requires providers to conduct an in-person medical evaluation prior to prescribing controlled substances to the patient.

Additionally, under non-PHE conditions, the CSA requires practitioners to obtain a separate Drug Enforcement Agency (DEA) registration in each state in which they practice. Due to the PHE, the DEA currently has exceptions that permit controlled substances to be prescribed via telehealth without an in-person examination. Practitioners can also prescribe controlled substances in any state so long as they are registered with the DEA in at least one state. Both exceptions are explicitly linked to the PHE, and upon expiration of the PHE, the stricter requirements of the CSA will once again govern prescribing practices.

On February 24, the DEA announced proposed permanent rules for prescribing controlled substances through telemedicine. The proposed rules would provide narrow and limited instances for prescribing controlled substances via telemedicine without first conducting an in-person evaluation of the patient after expiration of the PHE. The timing of this announcement, and the following 30-day comment period, suggests the DEA is attempting to implement these changes prior to May 11. Without such a change prior to May 11, providers should anticipate the inperson exam requirement will be enforced in most situations where a course of treatment warrants the utilization of controlled substances.

Although not strictly linked to the PHE period, Medicaid's "continuous enrollment" provision is set to expire on April 1. The continuous enrollment provision has been used to expand and maintain Medicaid coverage to an estimated 8.2 million Americans by requiring states to maintain Medicaid coverage and barring terminations during the PHE. As of April 1, states returned to reviewing each enrollee's eligibility and terminating non-eligible enrollees. Providers should review the Medicaid status of their patients to ensure accurate accounting and that patients do not become personally responsible for treatment.

### **Future Changes**

The Consolidated Appropriations Act of 2023 decoupled several PHE provisions from the PHE period and established December 31, 2024 as the date for a phase out of selected rule changes. The following provisions will continue until December 31, 2024:

- Providers can bill Medicare for telehealth services rendered to enrollees, regardless of the patient's or provider's location at the time of service.
- Audio-only telehealth visits are reimbursable.
- Expanded provider types eligible to deliver telehealth services, including audiologists, occupational and physical therapists, and speech language pathologists.
- Recertification for hospice care can be conducted through telehealth.
- Federally Qualified Health Centers and Rural Health Clinics can provide telehealth services to Medicare beneficiaries.

### **LEGAL**

The COVID-19 vaccination requirement for designated health care workers will not be affected by the PHE expiration. The requirement was instituted through a Centers for Medicare and Medicaid (CMS) Condition for Coverage and survey rule change and is unrelated to the PHE declaration. Moreover, President Biden has indicated he will veto any Congressional bill that would eliminate COVID-19 vaccine mandates for health care providers. Hence, it is unlikely the vaccine requirement will significantly change. Providers will need to ensure continued adherence to CMS rules regarding vaccination status and documentation.

It is imperative that providers are aware of how the expiration of the PHE impacts their prescribing, billing, and practice, and prepare for a post-PHE regulatory environment accordingly.


